#### Engineering

 Preliminary Engineering for the Hudson Tunnel Project reached 10% design to support development of the Draft EIS. Additionally, permitting efforts are well underway, and contract packaging efforts are advancing that will allow for an expedited start of construction while maintaining flexibility in project delivery approach.
