## **Gateway Development Corporation Trustees Welcome Jerry Zaro** *New Jersey Representative on Board of Trustees Focused, Enthusiastic*

NEWARK – The Trustees of the Gateway Program Development Corporation welcomed Jerry Zaro to the Board today as the representative of the State of New Jersey. Mr. Zaro was appointed to the role by NJ TRANSIT in April, at the suggestion of New Jersey Governor Phil Murphy.

“I thank Governor Murphy for his confidence in entrusting me with this enormous responsibility,” **Mr. Zaro said**. “Gateway, being the most urgent infrastructure project in the nation, is vital to both commerce and commuters, not only in the great state of New Jersey, but to our partners in New York, all along the Northeast Corridor and beyond. He has served the last seven consecutive Governors of New Jersey in a variety of leadership posts including Chairman of the New Jersey Highway Authority, Commissioner of the NJ Sports and Exposition Authority and as Chief of the Office of Economic Growth for the State of New Jersey, a cabinet-level position.

*The Gateway Program is the most urgent infrastructure program in the country – a comprehensive rail investment program that will improve commuter and intercity services, add needed resiliency and create new capacity for the busiest section of the Northeast Corridor (NEC). The NEC is the most heavily used passenger rail line in the country hosting more than 2,200 train movements and 800,000 passenger trips daily. The Gateway Program Development Corporation is a New Jersey not-for-profit entity with Board members appointed by Amtrak and the States of New York and New Jersey. It was incorporated in 2016 to oversee and effectuate the Gateway Program in coordination with federal and local partner agencies.*
